- c) Motion by Nancy 2nd by Liam to put 6" of gravel and pave Binder Rd. approximately \$170,000. All ayes, motion carried.
- d) Moe's is working on cleaning up their blight situation.
- e) Motion by Jeff 2nd by Tony to approve dust control. All ayes, motion carried.
- f) Motion by Liam 2nd by Tony to approve Resolution to establish a policy regarding the accessibility of the assessor's office to the taxpayers. All ayes, motion carried.
- g) Motion by Tony 2nd by Liam to give the Marijuana Farms a grace period to pay for the licenses. They must pay their late fees by April 15, 2026, but they get 60 days to pay for the licenses. They will get a temporary license. All ayes, motion carried.

10 . Planning Commission Report:

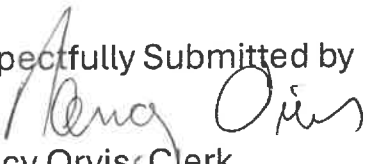
- a) We kept the dates for the meetings the same. No changes.
